

## **PRIVACY STATEMENT**

This website, [www.jcmsprorewards.com.my](http://www.jcmsprorewards.com.my), is owned and operated by JCMS ProRewards Sdn Bhd. We are strongly committed to maintaining the privacy and protection of your personal information. This Privacy Policy tells you about the information we collect on this site and how we use that information. By using this site, you are consenting to the information collection and use practices described in this Privacy Policy, which we may modify from time to time without prior notification.

- **Personal Information**

We only collect the personal information you want to provide to us or that is needed to provide (and improve) our service to you. We collect direct personal information such as name, address and email address as well as indirect information such as cookies, connection and system information.

We will not share your personal information with any third parties without your consent, except as necessary to provide you with the services offered by us or to comply with the law.

We do not rent, sell, or trade any personally identifiable information to other companies or individuals in our day-to-day operations. Non-personally identifiable information such as number of daily visitors or order amounts in a particular time period will not be used for any corrupt or unlawful purposes. Our business is to sell merchandise to you, not trade in confidential information.

- **Access to Personal Information**

Only authorized JCMS ProRewards Sdn Bhd employees and relevant third-parties (such as delivery companies who have contractually agreed to keep all information private and secure) have access to your personal information. All our employees who have access to your personal information are required to adhere to our strict Privacy Policy guidelines and all third-party employees who have access to your personal information have signed non-disclosure agreements. In addition, agreements are in place with third-party companies that have access to your personal information, to make sure this information remains secure. To ensure your personal information is protected, we

maintain a secure IT environment that has appropriate measures in place to prevent unauthorized access and system abuse.

- **Disclosure of Personal Information**

We may disclose personal information if required to do so by law or in the good-faith belief that such action is necessary to:

- Conform to the law or comply with any legal process served on the JCMS website;
- Protect and defend the rights or property of JCMS ProRewards or the users of this site;
- Act under circumstances to prevent fraud and to protect the safety of the public or users of this site.

- **Cookies**

From time to time, we may use the standard “cookies” feature of major browser applications that allows us to store a small piece of data on your computer about your visit to our site. We do not set any personally identifiable information in cookies, nor do we employ any data capture mechanisms on our website other than cookies.
